Key Themes for this Week

India's MSCI Index weight hits record high, expected to attract c.USD 3.0 bn inflows

India's weight on the MSCI Global Standard index, which tracks emerging market stocks, has reached a record high of c.19.8%, up from c.19.2%. This increase is expected to attract c.USD 3.0 bn inflows into Indian equity markets. The weightage change will be effective after the market closes on August 30, with further potential growth to above c.20.0% by November. Additionally, about 25 stocks will be added to the MSCI India Small-cap index.

The Increase in India's index weight signifies a growing investor confidence and attractiveness of Indian markets. The anticipated inflows could bolster market liquidity and provide a positive boost to Indian equities. This increased visibility on a global stage could further enhance India's economic growth prospects and investment appeal, potentially leading to greater capital inflows and a stronger domestic market performance.

ISRO achieves milestone with successful SSLV-D3 launch of earth observation satellite

The Indian Space Research Organisation (ISRO) successfully launched its Small Satellite Launch Vehicle-03 (SSLV-D3), completing its third and final development flight. The SSLV-D3 is ISRO's smallest rocket, capable of deploying satellites weighing c.500.0 kg into Low Earth Orbit. The mission's primary goals included advancing microsatellite design and developing payload instruments for future operational satellites. The Earth Observation Satellite deployed carries three payloads for environmental and disaster monitoring, ocean and soil studies and radiation monitoring.


This successful launch enhances ISRO's capability to offer cost-effective small satellite launches, benefiting NewSpace India Ltd, ISRO's commercial arm. It opens new avenues for commercial satellite deployments and strengthens India's position in the global space market, fostering growth and innovation in the domestic space industry.

Vinesh Phogat welcomed home with tears and cheers after CAS denies shared silver medal

Indian wrestling star Vinesh Phogat made a poignant return to India, where she received a warm and emotional welcome from fans, friends, and family. This reception followed a challenging period after her disappointing experience at the Paris Olympics, where she was disqualified during the gold medal match for being 100 grams over the weight limit. The Court of Arbitration for Sports (CAS) recently denied her appeal for a shared silver medal, upholding the International Olympic Committee's decision.

Despite the setback, Vinesh's performance in Paris was notable, including a significant victory over Japan's Yui Susaki, a defending champion. In the wake of the disqualification, Vinesh announced her retirement from wrestling. The emotional airport reunion highlighted the strong support and camaraderie within the wrestling community.


