

**Deals** 

- During the last week, 14 Indian start-ups received a total funding of c.USD 89.2 mn, while the details of other 2 remained undisclosed
- Out of the total, c.USD 26.7 mn was in the form of equity funding across eleven early-stage deals, while another
  one start-up raised c.USD 10.6 mn in growth-stage equity round
- One start-up raised c.USD 11.9 mn in debt funding, while another one raised c.USD 40.0 mn in mix of debt and equity funding

#### Major Developments in Start-up Space

- Trillion Dollar Ventures, an early-stage venture capital firm, has floated its second fund with a target corpus of c.USD 5.9 mn across sectors
- ONDC, a digital ecommerce platform, has facilitated the first mutual fund transaction on its network




#### Segment wise Funding Break-up (USD mn)
