

Indian Start-up Ecosystem

Overview

C.USD 202 mn 7 Funding Start-ups M&A this week raised funds Deal

- During the last week, 5 Indian start-ups received a total funding of c.USD 202.0 mn, while the details of other 2 remained undisclosed
- Out of the total, c.USD 67.0 mn was in the form of equity funding across four early-stage deals, while another three start-ups raised c.USD 135.0 mn in growth-stage equity round



Major Developments in Start-up Space

- RBIH, a subsidiary of RBI, has developed MuleHunter AI, an artificial intelligence and machine learning model to help banks and financial institutions detect mule accounts used by fraudsters
- Cashfree, a fintech start-up, has received the RBI's prepaid payment instrument (PPI) licence to facilitate purchase and fund transfer against a preloaded value




