

#### Overview

# C.USD 28 mn 7 2 Funding Start-ups M&A this week raised funds Deals

- During the last week, 6 Indian start-ups received a total funding of c.USD 27.7 mn, while the details of 1 other remain undisclosed
- Entire c.USD 27.7 mn was in the form of equity funding across six early-stage deals



## **Major Developments in Start-up Space**

- RBI has constituted a panel to develop responsible and ethical enablement of artificial intelligence (FREE-AI) for the fintech sector
- Enlighten Capital, a venture capital firm, has raised c.USD 12.0 mn from Limited Partners for its maiden alternative investment fund (AIF), which will focus on early-stage start-ups in emerging technologies, smart manufacturing, and EV sectors





- Nazara Technologies, a gaming platform, has increased its stake in its subsidiary Absolute Sports, a sports and gaming media company, to c.81.9% from c.71.7%, for a consideration of c.USD 8.6 mn
- Zaggle, a fintech company, has raised c.USD 70.0 mn through qualified institutional placement
- MobiKwik, a fintech company, has observed a block deal worth c.USD 13.9 mn with a sale of c.18.4 lakh shares by multiple investors including Peak XV Ventures

## **Strategic Transactions**


- TVS Motor, an automobile company, has acquired an additional stake of c.39.1% in DriveX Mobility, a two-wheeler start-up brining its total stake to c.87.4%, for a consideration of c.USD 11.5 mn
- MammyIndia, a GeoTech company, has acquired c.19.8% stake in Kaiinos Geo Spatial Technologies, a location intelligence platform, for a consideration of c.USD 0.2 mn


