Key Themes for this Week

India overtakes Japan as the top investment destination in the Asia-Pacific region

India has emerged as the most preferred investment destination in Asia, overtaking Japan and China, according to a May 2025 survey by BofA Securities. Around 42% of Asia fund managers are now overweight on Indian equities, up from 39% in April, highlighting a growing tilt toward India amid global portfolio realignments. The country is benefiting from shifting global supply chains, tariff recalibrations, and strong domestic consumption.

India also leads Asia in IPO activity and continues to attract significant foreign direct investment (FDI), crossing the USD 1 trillion mark cumulatively since 2000. Despite some concerns over earnings momentum, the outlook is broadly optimistic. India's youthful demographics, resilient GDP growth, and rising power status in the region further bolster its long-term appeal as a leading investment hub in the Asia-Pacific region.

Retail inflation drops to 6-year low of 3.16% in April

India's retail inflation eased to 3.16% in April 2025, down from 3.34% in March, marking the third straight month below the Reserve Bank of India's (RBI) 4% target. This is the lowest inflation level in nearly six years and was driven largely by a sharp 11% year-on-year decline in vegetable prices, along with moderation in other food items. Core inflation remained stable, suggesting sustained disinflationary momentum.

The easing of price pressures offers the RBI more room to consider rate cuts to support economic growth, especially as inflation continues to stay well within comfort levels. Economists had expected inflation to fall to around 3.27%, but the actual number undershot forecasts, boosting market sentiment. While food inflation could remain volatile due to seasonal factors, the broader trend points toward price stability.

Global cricketing icon Virat Kohli retires from test cricket

Virat Kohli has announced his retirement from Test cricket, concluding a distinguished 14-year career. He played 123 Tests, scoring 9,230 runs at an average of 46.85, including 30 centuries. As captain from 2014 to 2022, he led India to 40 victories in 68 matches, becoming the country's most successful Test skipper.


Kohli was instrumental in transforming India's Test team, emphasizing fitness and aggressive play, and fostering a formidable pace attack. His dynamic presence and leadership elevated the profile of Test cricket, both in India and globally. In his retirement statement, Kohli expressed deep gratitude for the format, stating, "I've given it everything I had." His departure marks the end of an era, leaving a significant void in the sport.





- CLSA, a capital market and investment firm, has divested c.1.2% stake in Edelweiss, a Financial Services company, for c.USD 11.8 mn through an open market transaction
- As per media reports, Sumitomo Mitsui Financial Group (SMFG), a Japan-based financial services group, may merge SMFG India Credit, its Indian non-bank arm, with YES Bank after its group entity SMBC completes acquiring c.20.0% stake in YES Bank
