

## Indian Start-up Ecosystem

#### Overview

# C.USD 139 mn 20 2 Funding Start-ups M&A this week raised funds Deals

- During the last week, twenty Indian start-ups received a total funding of c.USD 139.2 mn
- Out of the total, c.USD 85.2 mn was in the form of equity funding across seventeen early-stage deals and one startup raised c.USD 40 mn through a mix of primary and secondary funding
- Two startups raised c.USD 14.0 mn through debt funding



#### **Major Developments in Start-up Space**

- Kriscore Capital, a venture capital firm, has marked the first close of its maiden c.USD 11.7 mn fund, focused on technology driven startups across sectors
- BAT VC, a venture capital firm, has announced its India foray with the launch of a c.USD 100.0 mn fund to back earlystage startups across sectors such as AI, fintech and SaaS








