

Overview


C.USD 294 mn Funding this week Start-ups raised funds Start-ups Deals

- During the last week, fourteen Indian start-ups received a total funding of c.USD 294.0 mn, while the details of 1 other remained undisclosed
- Out of the total, c.USD 63.4 mn was in the form of equity funding across eight early-stage deals, while 6 start-ups raised c.USD 230.6 mn in growth-stage equity round



Major Developments in Start-up Space

- Physis Capital, a venture capital firm, has raised c.USD 25.0 mn for its maiden fund, to invest in tech-driven startups
- Avaana Capital, a venture capital firm, has made a withdrawal of c.USD 24.5 mn from the Green Climate Fund, a sustainability-focused fund for developing countries, to the Avaana Sustainability Fund, a fund that invests in earlystage, climate tech companies






Segment wise Funding Break-up (USD mn)
