- During the last week, twenty-one Indian start-ups received a total funding of c.USD 298.5 mn
- The total funding, c.USD 298.5 mn was in the form of equity funding across twenty-one early-stage deals

#### Major Developments in Start-up Space

- Speciale Invest, a venture capital firm, has announced the close of its third fund at c.USD 70.0 mn, to invest in startups over the next four years across spacetech, advanced manufacturing, energy, healthtech, and AI sectors
- Atomic Capital, a venture capital firm, has announced the close of its first fund at c.USD 47.1 mn, to invest in startups across food & beverages, personal care, and apparel sectors






