Key Themes for this Week

New GST reform launched: simplified to 5% & 18% slabs, luxury tax at 40%

On September 3, 2025, the GST Council approved a revamped tax framework, reducing India's Goods and Services Tax to a dual-rate structure of 5% and 18%, eliminating the existing 12% and 28% slabs. The revision takes effect from September 22 and is expected to reduce revenue by approximately INR 93,000 crore, although the introduction of a 40% tax slab for luxury and sin goods could recoup about INR 45,000 crore. Decisions were made by consensus, with no final clarity yet on state compensation for revenue losses.

This sweeping reform, endorsed by the GST Council under Finance Minister Nirmala Sitharaman's leadership, marks a significant simplification of India's indirect tax regime. While the dual-rate model aims to ease compliance and stimulate economic activity, states such as Punjab and Jharkhand voiced concern over fiscal shortfalls, urging compensation to cushion the transition.

Nifty 50 outpaces MSCI India in P/E for first time since 2017

The Nifty 50 index has surpassed the MSCI India Index in one-year forward price-to-earnings (P/E) valuations for the first time since 2017, driven by the inclusion of higher-valued stocks. As of recent data, Nifty's forward P/E stands at 22.77x, compared to 21.83x for the MSCI India Index. This marks a reversal of the traditional trend, where MSCI India usually trades at a premium to Nifty, reflecting a shift in the composition of the benchmark index.

This rise is primarily attributed to the growing weight of sectors and companies aligned with high-growth and digital-focused business models. The evolving index composition has led to an increased representation of premium-valued firms, resulting in higher overall valuations and narrowing the gap with global benchmarks.

India submits official bid to host 2030 Commonwealth Games


India has officially submitted its bid to host the 2030 Commonwealth Games, selecting Ahmedabad as the proposed host city as part of its broader ambition to stage the 2036 Olympics. The Indian Olympic Association (IOA) approved the proposal in August 2025, and the Union Cabinet has endorsed the plan, including the signing of the Host Collaboration Agreement and required ministerial guarantees. The bid highlights inclusivity, sustainability, and long-term legacy benefits, with plans centered around the Narendra Modi Stadium, one of the world's largest sporting arenas.

India will compete with Nigeria, the only other country which submitted a formal proposal by the August 31 deadline. The Commonwealth Sport Evaluation Commission will now assess both bids before making its recommendation. The final decision on the 2030 Games host will be announced at the Commonwealth Sport General Assembly in November 2025.


