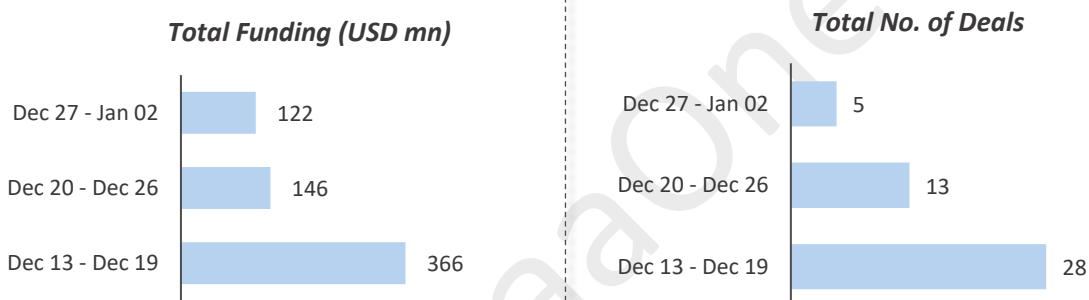

- During the last week, twenty-two Indian start-ups received a total funding of c.USD 78.1 mn while the details of 3 others remained undisclosed
- Out of the total, c.USD 71.8 mn was in the form of equity funding across twenty early-stage deals
- Two start-ups raised c.USD 6.3 mn in debt funding

### Major Developments in Start-up Space

- The Tamil Nadu Government has launched a deep tech start-up policy with outlay of c.USD 11.8 mn to promote startup sectors such as AI, blockchain, semiconductors, electronics manufacturing, spacetechnology, and animation

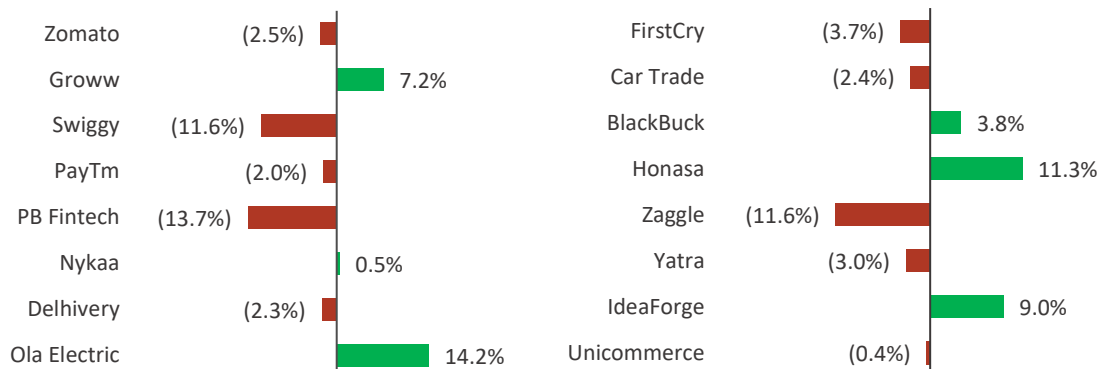

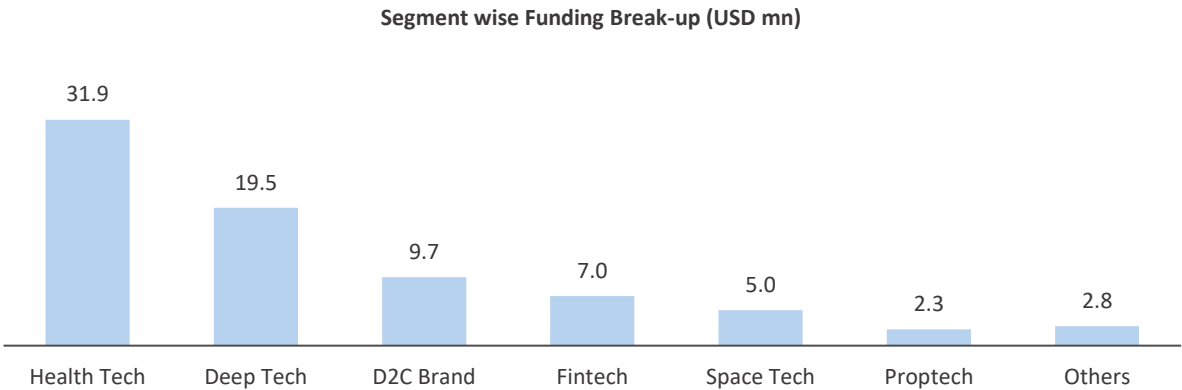
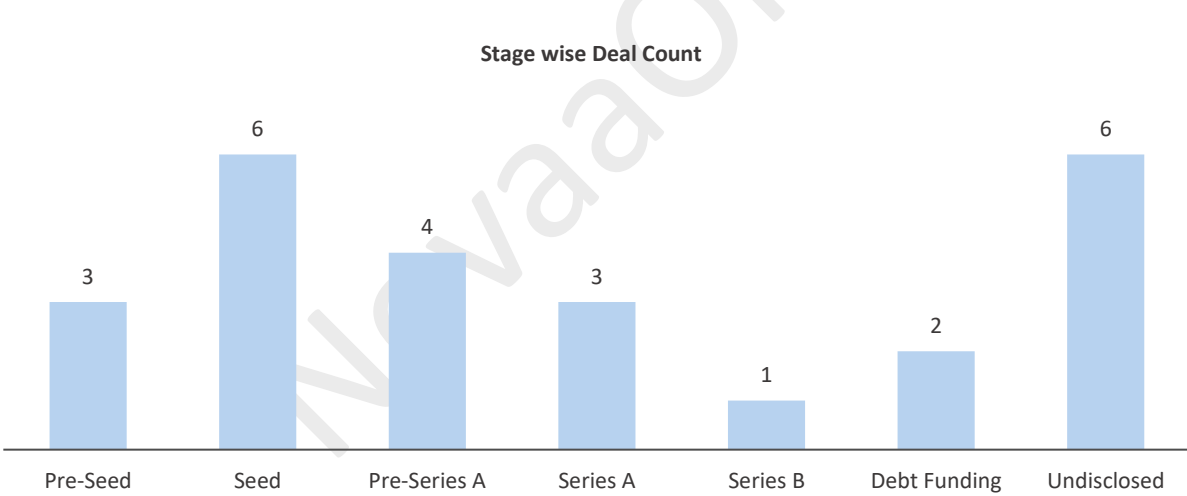
## Highlight of Significant Deals
